This research discussed the analysis of Directive Speech Acts in "The Boy Who Harnessed The Wind" movie. This research aimed to find out the kind of directive Speech Acts in this movie. The research design was descriptive qualitative research in which the writer interprets utterances that contain the types of directive speech acts in this movie, The source of data was taken from "The Boy Who Harnessed the Wind" movie. This thesis was to analyzed and described the directive speech acts presented in the movie based on Kreidler's Theory.

The researcher used observation sheet validation from Linguist, the script, and "The Boy Who Harnessed the Wind" movie as the instruments of the research. This research was analyzed by used Kreidler's theory. The classification of directive speech is into three kinds that are command, request, and suggestion. This study was found that characters on the movie used all kind of directive speech act based on the Kreidler's Theory.

It could be concluded that the result findings of the research showedthat all the types of directive speech act were by Kreidler's theory were found in that movie, they were command, request, and suggestion. Therefore, This Research showed that there were command act 11 occurrences, request act 20 occurrences, and suggestion act 12 occurrences.
